NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF HECTOR, ARKANSAS


The city council, after review, discussion, and consideration of Chambers Bank proposal, finds that the proposal is in the best interest of the citizens of the City of Hector, Arkansas.

The Bank will utilize A letter of credit from the Federal Home Loan Bank and/or the purchase of US Treasuries or Bonds would be utilized to ensure all deposited funds are fully collateralized. The Bank requests notice of any substantial deposits or withdrawals to ensure that the proper collateralization level is maintained at all times. The Bank will provide the Security Agreement for Funds Held in Deposit, Certificate of Corporate Resolution and Custodial Services Agreement as required.

(3) Standard Services
